1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Scope of Supply

3. Service & Support

Manner for submission of rates for above items:

The bidders need to submit the rates for all of the above work, and rates should be inclusive of all Taxes a nd duties including transportation cost.

- 2. Payment: 80% on successful completion of supply and duly accepted by NATRAX on submission of GST I nvoice, within 15 days from the date of acceptance & issuance of CRAC. 10% on successful completion of t raining to NATRAX representatives (at least 3 persons as nominated by NATRAX). Balance 10% (as perfor mance security/PBG) shall be paid after successful completion of warranty period. The payment of GST sh all be released only after submission of documentary evidence.
- **3. Delivery Period:** within **45 days** from the date of order, failing which NATRAX reserve the rights to impose LD /penalty of .5% per day of contract value up to maximum 10% of contract value.
- **4. Delivery Location:** NATRAX Pithampur OR as per consignee.

5. Warranty period: 3 years comprehensive AMC/Warranty from the date of acceptance by NATRAX.

- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.

- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
